RESORT GOLF MEMBERSHIP

Initiation Fee

- \$7,500

Monthly Dues: \$353 Dues per Month *Monthly dues are paid quarterly in advance*

Resort Membership available to an individual, spouse and children up to 25 years of age.

- **November 1 to April 30:** Play for per person Accompanied Guest of Member rate

LEGACY GOLF MEMBERSHIP

Initiation fee: \$10,000 One-Time Initiation Fee

Monthly Dues: \$356 Dues per Month *Monthly dues are paid quarterly in advance*

Legacy Golf Membership will be extended to the children of existing Full Golf Members, who are at least 25 years old and provides the same benefits as the Full Golf Membership (see above)

Legacy Golf Membership is limited to 100 Memberships

YOUNG EXECUTIVE GOLF MEMBERSHIP

Initiation fee: \$12,000 One-Time Initiation Fee

Monthly Dues: \$364 Dues per Month. *Monthly dues are paid quarterly in advance*

Offered to young adults between the ages of 25 to 39 and provides the same benefits as the Full Golf Membership (see above)

At the age of 40, the membership will require higher monthly fees or reclassification. (See Membership Manager for details)

Young Executive Golf Membership is limited to 100 Memberships.
